NET METERING CUSTOMERS may now select their Regulated Price Plan option. This new option is available though your utility's portal.

EQUAL PAYMENT PLAN: Your utility offers an Equal Payment Plan. It is available for residential, seasonal, and small general service customers. Contact your utility to learn more.

OPENING AND CLOSING ACCOUNTS requires a minimum of 7 days notification prior to the change.

LOW INCOME CUSTOMERS can have their deposit refunded. Please contact your utility for more information.

ELECTRONIC COMMUNICATION customers who have provided your utility company with an e-mail address have agreed to receive electronic information. If you wish to opt out of this option, please contact your utility.

NEW DISTRIBUTION RATES are proposed to be in effect as of January 1, 2025. Information about rates can be found on your utility's website.

HIGH WINDS AND DOWNED POWERLINES

Fall and winter storms frequently bring high winds and trees coming down on or near powerlines is a reality. Powerlines on the ground can be energized and electrical hazards may be present, even if they can't be seen. Stay back at least 10 metres or 33 feet from downed powerlines and avoid clearing snow, ice, tree branches or other debris until your utility confirms it is safe. Immediately contact your utility to report downed wires!


STRAY VOLTAGE is the varying amounts of low-level voltage that exists between the earth and electrically grounded farm equipment. At high levels, the voltages cause a threat to the health and behaviour of livestock. If you think Farm Stray Voltage is harming your livestock, please call your local utility for an inspection. tree branches or other debris until your utility confirms it is safe.
